# SUMMER CAMP INFORMATION

## General Information

Our camp is offered to skaters of all levels, ages 6-14. All skaters are welcome and no skating experience is required. Staffed by the professional figure skating coaches of Ice in Paradise, our camp is an opportunity for skaters of all skill levels to get an edge on their skating skills, meet new friends, and have a great time!

**Camp hours are from 8:30am to 4:00pm.** Check-in begins at 8:15am and ends at 8:30am. Check-out begins at 4:00pm and ends at 5:00pm. Skaters need to be signed-in and -out each day. Accommodations may be made if skaters need to be dropped off earlier or picked up later.

Lunch will be provided by various caterers and is included in the registration fee. Snacks will be provided twice a day. All skaters should bring plenty of water and extra snacks. Please note any food allergies in the medical information section of the registration packet and we will provide alternative meals.

Skaters should wear/bring warm clothing (long pants, jacket/sweater, warm beanie, layered clothing, gloves), long socks, and tennis shoes. Skaters who do not own skates will be provided with rental skates.

Phones, iPods, and electronics need to remain out of sight and should not be used during camp. If there is an emergency, please contact the ice rink at (805) 879-1550.

On **Friday, June 15<sup>th</sup>** from 3:00-4:30pm, all families of skaters in the summer camp are invited to join us on the ice during a public skating session. Admission is free and skate rentals are \$2.50 if needed.

## Registration/Price

The full price of camp is \$395, which includes skate rentals for those who need skates, lunch, snacks, craft activities, ice time, and group lessons. Pages two through four of the packet must be completed in their entirety and returned to the front desk of Ice in Paradise with payment for each skater attending camp. There is no half-day camp option and there are no refunds for partial days. Registration deadline is **Tuesday, May 29<sup>th</sup>**.

**Early registration** – Register by **Monday, May 7<sup>th</sup>** to receive \$20 off.

**Sibling discount** – The first child is full price. Each additional sibling registered will receive \$20 off.

## Minor Waiver of Liability, Release Assumption of Risk and Indemnity Agreement

I, \_\_\_\_\_, the parent/guardian of \_\_\_\_\_, (hereafter referred to as "Child") hereby waive, release and indemnify Ice in Paradise (hereafter referred to as "IIP") and its employees, directors and affiliates of and from and all claims, demands, debts, contracts, expenses, cause of action, lawsuits, damages and liabilities, of any nature, whether known or unknown, in law or equity, that I or Child ever had or may have arisen from or in any way related to Child's participation in any of the events or activities conducted by, on the premises of, or for the benefit of, IIP provided that this waiver of liability does not apply to any gross acts of negligence or intentional misconduct.

In consideration of being allowed entry onto the premises of Ice In Paradise ("IIP"), I agree that IIP is not in any way responsible for any loss or damage sustained by me or Child, including injury to person or property, whether or not it may have been caused or contributed to by any negligence on the part of IIP, its staff, representatives, volunteers or agents. I understand that entry onto the premises of IIP, and participation in activities at IIP, carry inherent risks that cannot be eliminated regardless of care taken. I, on behalf of myself or Child, hereby release, waive, discharge and indemnify IIP, its officers, employees, volunteers, representatives, agents and affiliates, from any and all liability arising out of or connected in any way with my or Child's entry onto the premises, whether or not caused by the negligence of any of the above persons or entities. I voluntarily assume all risks of loss, damage, or injury that may be sustained while entering onto the premises. Such risks may include, but are not limited to, risks associated with activities both on/off the ice surfaces, whether related to sports recreation, participation in or attendance at IIP or IIP-sponsored events. In addition, I agree to hold harmless from any and all claims, damages, losses, liabilities and costs (including without limitation reasonable attorneys' fees, expert witness expenses, litigation costs, and disbursements) all the entities and persons mentioned above who otherwise might be liable to me or my successors for damages. I agree that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the laws of the State of California, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
